Dr. Amy Quinn has her doctorate in educational leadership and is a licensed Marriage and Family Therapist specializing in treating teen and young adult bipolar disorder, depression and anxiety. She is also certificated in Eye Movement Desensitization and Reprocessing (EMDR) therapy, a specialized treatment for trauma. An additional master's degree she possesses is in organizational behavior and evaluation science. She has extensive experience designing, implementing and evaluating prevention interventions in school districts, organizations and non-prof-

its. Her previous experiences in academia include serving as an Adjunct Faculty in the Graduate Program of Organizational Psychology at Vanguard University of Southern California where she taught Applied Research Methods, Stress and Health in Organizations and advised students on their research projects.

Dr. Quinn most recently earned her EdD in Educational Leadership from Northwest Nazarene University, where she did extensive research on how burnout and compassion fatigue develops for those professionals working in the mental health field. She has published several articles on teen mental health, resilience, complex PTSD, and trauma at GoodTherapy.org. She enjoys helping teens and young adults reach their full potential through her private therapy practice in Naples, Florida.

As the executive director of the Fountain 33 Foundation, she is responsible for engaging in philanthropic efforts focused on mental health prevention and education. Dr. Quinn currently serves as a trustee for the Naples Children and Education Foundation, a trustee for the Community School of Naples Board of Trustees, and an advisor on the Kids Minds Matter Community Advisory Committee. #### **Eileen Voynick** Chairman of the Board at AGS Health and Director at CDK Global

Eileen is Board Chair of AGS Health, and formerly served as a member of the Board of Directors of r3 and Skydeck. She was also an Independent Director of Advanced MD (Salt Lake City UT) during their ownership by Marlin Equity. The business was successfully sold in 2018 to Global Payments. Additionally, she was a Board Director at CDK Global (CDK) for the six years prior to it's sale to Brookffeld Private Equity for \$8.3 billion.

Eileen is the former CEO of Sparta Systems, a leading global provider of enterprise quality management software solutions, where she provided focused vision, leadership, and strategic direction. During Eileen's tenure Sparta transformed itself from a steady state to accelerated growth company, doubling revenue, while maintaining strong profitability. Further, Eileen led a competitive and successful transaction in 2014 that resulted in the company's sale to leading private equity firm Thoma Bravo. In 2017 she led a second transaction where New Mountain Capital purchased a majority share of Sparta. Sparta was purchased by Honeywell in 2021 for \$1.3 Billion.

Prior to joining Sparta, Eileen was already a highly successful enterprise software industry executive, known for her ability to implement change and enhance customer success leading to profitable growth and increased company valuation. As the Chief Operating Officer of Allscripts, a provider of clinical software, information and connectivity solutions for physicians, Eileen drove significant growth in profits and revenue and developed an extensive product portfolio. She was also instrumental in helping the company to successfully acquire Eclipsys, a \$1.3 billion transaction.

In addition, Eileen was an Executive Vice President at SAP during its formative hyper growth years in the mid-1990's, improving revenue from \$100 million to more than a \$1 billion. In the mid-2000's, as Siebel Systems' Senior Vice President of Global Services, she had general manager responsibility and helped to create the Customer Experience Blueprint Program, which was later issued a U.S. patent.

She subsequently joined Oracle's North American executive team as the Senior Vice President of Americas Consulting, a more than \$1 billion organization with over 5,000 associates.
